**Show rules:**

All FIFe show rules are valid and applicable. Exhibitors or persons authorized by them may present the cat to the judges themselves but a steward will be at their disposition. Throughout the exhibition cats have be kept in decorated cages. Participation is at risk of the exhibitor, no claims for damages will be accepted. All changes in classes must be announced to the show secretariat until 9:00 am. Early exit from the exhibition is possible only with the consent of the exhibition committee and a charge of 5 €.

**Chairs are available.** Free parking in near neighborhood of BVV.

**Veterinary rules:**

The cats have been vaccinated by a veterinarian in accordance with each country's veterinary regulations, against feline panleucopenia, feline calicivirus and feline herpesvirus, and have had the required boosters, at least 15 days prior to the show. The period of the validity for the vaccination is marked by the veterinary surgeon in the pet passport or on the vaccination certificate. Vaccination against rabies is to be according to national legislation - all cats living outside of the Czech Republic must be vaccinated against Rabies. White cats must have a certificate stating that they are not deaf.
